

**President's Report**

- No separate President's Report this month. There will be a letter in the newsletter, and the newsletter will be going out on Friday.

**Secretary's Report - Motion made to approve secretary's report by Terri Myhre. Angie DeVos seconded the motion. Motion carried.**

**Treasurer's Report**

- **Bills:** Bills for the month of December were sent out prior to the meeting for review. Total General Fund bills are estimated at \$8,441.78 with two additional bills for the building fund.
- **Motion made by Terri Myhre to approve the Treasurer's Report. Deb Belaen seconded the motion. Motion carried.**

**Board of Trustees Report**

- **Bills:** Total General Fund bills are estimated at \$8,441.78 with two additional bills for the building fund: garage door parts from Minneota Building Materials and rental of lift for trimming trees from Kesteloot's. Total building fund bills are \$546.85.
- **Date for year-end cutoff:** The cutoff date for donations will be December 29<sup>th</sup>; this will allow for online donations to get into the account prior to the end of the year.
- **MN ESST and Paid Leave:**
  - MN Earned, Sick, Saved Time - Minnesota law requires employers to provide earned sick and safe time (ESST), a type of paid leave, to workers in the state. An employee earns one hour of sick and safe time for every 30 hours worked and can earn a maximum of 48 hours each year. It allows for accrual and use of paid time off and provides job protections for employees who are unable to work due to a qualifying reason. At the end of the accrual year, your employees carry over or are paid out unused ESST hours, depending on how you have chosen to provide ESST hours. Chris is eligible for this, while Jason is considered a contractor. There are 3 different ways to manage this, and the options are below:
    - Option 1 - Employee receives at least 80 hours a year, and if it is not used, it can be carried over to the next year.
    - Option 2 - Employee receives 48 hours a year, and if it is not used, it is paid out at the regular hourly rate.
    - Option 3 - Employee receives at least 80 hours, and if it is not used, you will lose it.
  - It was recommended that we go with option 2, and we include the 48 hours as a separate budgetary line item. This eliminates the need for tracking hours carried over year to year.
  - Paid Leave - Beginning January 1, 2026, MN employers need to provide job protections and partial wage replacement for individuals unable to work due to a qualifying condition lasting at least seven days. It is funded through employer and employee premiums starting in 2026. We need to set up an online account, and Amie is still working to get us registered.
  - Amie has drafted a policy and sent it to the council.
  - We have to provide notice of the policy to any new employee; Chris was notified prior to the December 1, 2025 deadline.
  - The council president and council secretary need to be notified if an employee is planning to take paid leave.
  - Planning to use one workday as the minimum paid leave increment for this policy.
  - It was recommended that we don't do more than the minimum requirements.
  - These need to be approved by January 1<sup>st</sup>. Amie will be sending out an e-mail with the revised policy, and will need a motion to approve, a second, and everyone will need to vote. Please reply all when responding to make sure everyone is on the whole chain.
- **Budget Planning:** The trustees have a budget planning meeting scheduled for December 22<sup>nd</sup>. If there is anything specific that you want to be considered, please let us know prior to that meeting.
- **Ordination Process Application:** Jenn has requested \$500 for the ordination process application. **Motion made by Barb Knutson to pay \$500 from the undesignated memorial fund for the ordination application. Angie DeVos seconded the motion. Motion carried.**

  - We will be wrapping games and assembling hygiene bundles (deodorant, shampoo, toothpaste, etc.) on Wednesday, December 10<sup>th</sup>.
- **Teen Power:** They are starting their annual Teen Power Shoe Collection. Please drop off any worn out shoes, boots, tennis shoes, slippers and sandals at church. The goal is to donate more than 700 pairs of shoes that were donated last year.

### Other Business

- **Peter Soli Meeting:** The meeting is scheduled for Sunday, December 14<sup>th</sup> after worship. Muffins and fruit will be available during the meeting. On Wednesday, December 17<sup>th</sup> at 7:30 pm there will be a Zoom meeting as a follow-up to Sunday's meeting for those who can't attend on Sunday or if there are additional questions.
- **Monthly Items:** A google document has been created for the monthly "to do" items of the church. Please make additions and edits as needed.
- **Nominating Committee:** Rose, Barb, Emily, and Terri have completed their 2<sup>nd</sup> 3-year terms on council. Thank you very much for your service! Angie is completing her first 3-year term. Jeff's term will also be completed, and since he was completing a term for someone else, he is eligible to be nominated for a full term. The Nominating Committee is Roberta Josephson, Kevin Larson, and Moriah Reiss. Lori Dyce is also willing to serve on the council, so her name can be added to the ballot.
- **Call Committee Update:** Jeff provided an update from Dawn about a potential pastor that had approached us through our Linked In post. The response time from the synod was slow, and there was concern from the call committee about the response from the synod with this individual's years of experience.
- **Updating locks:** Southwest Glass can't do an automatic lock. We do need to get everything re-keyed. Jeff suggested using Yale Locks as you can assign key codes to different people; the cost is approximately \$150 per door. We will continue to research who could install this type of lock.
- **Communication system:** Amie would like to get a system in place that we can use for weather, announcements, etc. The recommendation from Amie is to use Text in Church, which is what she and Chris had tested. This program allows people to sign up themselves. Amie would like to have a decision made by the next meeting.

### Hope Lutheran Teen Power's Annual Shoe Collection

Clean out your closets and bring your shoes, boots, sandals, and other footwear to Hope Lutheran Church! Give away your gently worn shoes to help to provide shoes that aren't worn or an old pair that may end up in a landfill. We will gather footwear and deliver our donations to one of the drop-off points, Schuler Shoes in St. Cloud, MN. They shared with us that after the footwear is donated, the shoes are paired and sorted, and the footwear goes to four different places. The newer ones may be donated to the shelter food shelf and then sold at shelters for \$5.00/pair. The money is then donated to the shelter's food shelf. Some of the shoes stay in Minnesota with a program called "Shoe Away Hunger", and some go to other countries where they are needed for people without shoes. The rest, if pretty worn out, or are singles, are shredded and used for playground surfacing of rubber mulch. **Please clean out your closets and bring your bags and boxes of your household's gently worn footwear to Hope Lutheran Church.**

## From Jenn Warnock, Lay Minister

*“Where there is no vision, the people perish” Proverbs 29:18*

### **Happy New Year beloved people of God!**

As we greet the New Year, we often look forward with resolution(s), with vision. We renew commitments and we make goals and we envision successes. As Christians, and as Church, what is our vision for 2026 and beyond? Jesus tells his disciples in Matthew 6:21, “where your treasure is, your heart will be also”. Is Jesus our treasure? And, do we have a commitment to serving and following God? Do we follow our hearts to worship and to prayer and to community?

Now, everyone in Southwest Minnesota knows that the Minneota Vikings are an amazing and successful high school sports program across all teams! But, would the Minneota Vikings be as exceptional and successful as they are without **vision**, and without **commitment**? Imagine, if you will, that the athletes of Minneota only showed up for practice when they felt like it, or when there was nothing else to do? What if the parents never brought the athletes to practice or attended any of their games? Suppose the coaches would rather read the sports page or play games on their phones than care and coach? What if there was not adequate or consistent funding sources to support the program ? I think there would be a very different Minneota athletic world.

Where is our treasure, our hearts, our priorities as church? A church who values **God over All** will prioritize God's will and His way, His people and His house, His gospel and His mission over everything. In the manner that we support our sports, this includes consistent church attendance, consistent monetary support, and consistent community building within and without the church family. All my life, both as a pastor's daughter and pastor's wife, I have heard people make this statement: *“our church needs to grow, how do we make our church grow”*. Just like anything else, a garden, a family, a sports team, we nurture **what is important to us!** So many times, those same churches asking those questions are looking for something or someone to come in from outside and magically make everything the way that they want it. (Usually financially) Basically, if everyone is following the vision, and is committed, the church will be and will remain healthy. If we only attend worship when we feel like it, what if eventually nobody feels like it? Are we waiting for everyone else to contribute financially? Do we want the church to be there for our families for baptisms and confirmations and weddings, but we make no commitment to the church and are surprised when we show up one day and the church is no longer there? I live in a former church building and am reminded of this often. We drive by former church buildings that now function as community centers or daycare centers.

The church is more than our buildings , however, as beautiful as they are. The church is the body of believers, the Family of God. It is a spiritual bond. As we nurture our biological families, so should we care for and nurture our church family. It is important, it is worth commitment, it is worth following and sustaining the vision. We know God's plan for us as outlined by the prophet Jeremiah: “plans to prosper you, and not to harm you, plans to give you a hope and a future.” What are our plans? What is our vision for 2026 (and beyond)?

May God bless us everyone, and lead us in His way in this New Year!

## Council President's Report

December is a busy month, and this was certainly true at Hope Lutheran. The month was filled with many events and activities, supported by a great deal of behind-the-scenes work that made it all possible.

I am deeply thankful for all who put in extra time and effort preparing the church for the holidays; planning and providing music throughout the month; preparing for, participating in, and supporting the Minneota Mission Trip baking day; and planning, preparing, and supporting the Hope Lutheran Youth Ministries Christmas Program, among many other contributions. I am also grateful for your continued support of and presence at Hope Lutheran. Our members support in and for Hope Lutheran does not go unnoticed.

I would also like to express my appreciation to all who, despite many commitments at church and at home, participated in the initial meetings with Reverend Peter Soli. That being said, I understand - it was an absolutely busy time to be starting the process – so, do not be discouraged if time did not work for you to attend, you can pick right up by reviewing the letter that was sent out. Feel free to reach out with questions, concerns, or comments – and certainly we will take prayers as we start the work. Reflecting my interactions with Reverend Soli—both prior to and during December—I am encouraged by the breadth of experience he brings from his years serving congregations. He understands the day-to-day life and work of the church, having spent his vocation immersed in its ministry. This background and knowledge are new for Hope Lutheran, and it is clear that he is thoughtfully focused on our congregation and our future.

During one of our meetings, Peter invited everyone to share how they were doing. With my work life especially busy this December and being a mom of four teens/tweens—“providing the Christmas magic”—the season felt overwhelming. Another member shared that we had entered the season of Advent and that, for her, it was a time to slow down and reflect. Advent is meant to be a time to slow our pace and focus on the meaning of Christ’s coming and reign—a season of hope, peace, and watchfulness. Her reflection gave me pause as December and Advent have not felt this way for me in recent years or if I were to be honest with myself, perhaps this season has never felt this way to me. As I sat down to write this newsletter, this became an “aha” moment for me: a reminder of how much we need meaningful interactions across a broad cross-section of our congregation, where insight, perspective, and community can be shared.

Many members and groups met throughout December to prepare for the end-of-year. One of those groups was the Trustees, who met prior to Christmas to review the proposed 2026 budget for Hope Lutheran. This budget will be reviewed at the January meeting, after which the Council will finalize and vote on it. A bit different from previous years, there will also be an informal meeting and discussion regarding the proposed budget for those who are interested on the Sunday prior to the Annual Meeting. This approach was recommended as a best practice, and I look forward to the questions and dialogue that can take place ahead of the Annual Meeting so members feel informed and engaged.

You may recall that I previously shared that another congregational survey would be sent out before the Annual Meeting. I had not forgotten about this; rather, during planning conversations with Reverend Soli, he shared that he may recommend conducting a survey as part of his work with the congregation. In light of that, I felt it would be best to focus on Reverend Soli’s survey when the time comes. In the meantime, if you would like to share what you believe is going well, what could be improved, or any suggestions you may have, please feel free to reach out to me by phone or email.

This past year—and the holiday season—has been a difficult time for many. As we move into the new year, I want to continue to pray for understanding, patience, and empathy of others. We never truly know what is happening in another’s life or home, and if nothing else, we can always choose kindness.

As we begin the new year, I wish each of you peace, hope, and God’s blessings in the months ahead.
